**DIRECTIONS:**

**FROM CALGARY:** North on Highway 2 towards Edmonton. Take Exit #305. At the top of the ramp, turn left (West), go over the highway and turn right onto 2A North. Take 2A North approximately 6 km to Highway 580. Turn left (West) on 580 towards Cremona and travel approximately 6 km to Range Road 21. Turn left (South) on Range Road 21 and travel approximately 2 km to address 29457 on your left.

**FROM EDMONTON:** South on Highway 2 towards Calgary. Take Exit #315 (Carstairs). At the top of the ramp, turn right (West) and head towards the town of Carstairs. At the first traffic light in Carstairs, turn left onto Highway 2A. Travel South on 2A for approximately 4 km and turn right (West) onto Highway 580 towards Cremona and travel approximately 6 km to Range Road 21. Turn left (South) on Range Road 21 and travel approximately 2 km to address 29457 on your left.

**HANDLER PARKING:** Onsite camping available. No services. In the fenced in field immediately on your left as soon as you turn into the driveway.
